## NOTE:

(i) Tuition fee is subject to increase by 10% every year. Diet money is subject to revision keeping in view of inflation rate of dietary items.

(ii) On receipt of the documents as mentioned in para 6 below, your entitlement for the grant of Scholarship will be ascertained and if found eligible, the case for grant of Scholarship will be referred to concerned Govt for sanction. The amount of scholarship sanctioned, if any, will be refunded / adjusted against fee dues in the subsequent years of stay of cadet in the school.

3. Please note that the amount is to be paid by Crossed Bank Demand Draft <u>only</u> drawn in favour of <u>*PRINCIPAL*</u>, <u>*SAINIK*</u> <u>*SCHOOL*</u> payable at <u>*KAPURTHALA*</u> (*PUNJAB*)</u>. Payment in the form of Cheque / cash shall not be accepted.

4. Parents are to provide items as per <u>Appendix - A</u> of the school prospectus. The school will provide necessary items and clothing (as per Part II of the list after admission) to your son / ward to ensure uniformity in the pattern of clothing and other accessories being used by the students.

5. You are also requested to purchase the text books as per <u>Appendix - B</u> for your son under your own arrangements.

6. All parents are required to submit the following documents duly <u>attested by First</u> <u>Class / Executive Magistrate</u> and completed in all respects, at the time of admission.

#### (a) ESSENTIAL REQUIREMENT OF DOCUMENTS FOR ALL CANDIDATES

(i) <u>Proof of Age:</u> Date of Birth Certificate from the Registrar, Births & Deaths / Municipality to be produced, in original, for verification along with an attested copy. (As per Govt of India rules, the birth and death of an individual should be registered with the Registrar, Births & Deaths within 21 days of the same. If the birth of the student was registered after the stipulated period of 21 days, certified copy of supporting documents at the time of registration should also be produced to the school at the time of admission to verify the veracity of date of birth).

(ii) <u>School Leaving Certificate:</u> Duly countersigned by the concerned District Education Officer / CBSE / ICSE, as the case may be. It is mandatory for all the students studying in any school of the country to be registered on the portal of U-DISE (Unique District Information System of Education). <u>Please note</u> that the candidates are to bring the school leaving certificate generated by U-DISE duly signed by the Head of the institution for his registration as the student of this school.

(iii) <u>Domicile Certificate</u>: To be signed by the Sub Divisional Magistrate (Civil) of concerned district with one photograph of the cadet duly pasted on it. (In case of Defence Personnel, please bring a certificate from OC of your Unit showing the permanent address of the parent).

(iv) <u>Boys whose parents are Defence Personnel or Ex-Defence Personnel</u>: The date of birth entered in the service documents maintained in the Record Office of the respective services will be submitted. In case of children born after individuals release / retirement from service, the provision of para-6 (a) and above will be applicable.

(v) <u>Affidavit regarding Rules and Regulations</u> of Sainik Schools Society, Specimen signatures and permanent address of the parents duly attested by First Class/Executive Magistrate as per Appendix . C to be executed on nonjudicial paper worth Rs 25/- or above.

1. Cadets should be available in their respective dormitories during night prep time as attendance will be taken in your respective houses. Cadets should stay/sleep in the dormitory allotted to them. Staying/sleeping in others room is not permitted.

2. Any physical/mental harassment towards fellow cadets including ragging, quarrelling, using abusive language and violent behaviour is prohibited.

3. Use of any restricted drugs and alcohol is strictly prohibited inside the School and Hostel premises. If narcotics or related substances are or liquor (or empty liquor bottles) is found in any room, all the students staying in that dormitory are liable to be suspended with immediate effect. In addition, any student who consumes liquor in the hostel tries to bring liquor into the hostel or enters the hostel after consuming liquor will be expelled from the school.

4. Hostel is meant for facilitating cadets and for studies. Therefore, silence should be maintained any kind of sports activities are strictly prohibited in cadetsqcomplex. Cadets should not disturb other cadets by playing, conducting any kind of parties, talking loudly phone etc.
