For and on behalf of The Principal Sainik School Kapurthala, the bids are invited from bidders for **Dismantling of Overhead Water Tank and Old Bus Garage and quarters** at Sainik School Kapurthala as per advertisement published on 29 Nov 2024. Tender document may be downloaded from the website of **www.sskapurthala.com**. Bids in sealed cover are invited for the said work as per the scope of the work. Please super scribe the above-mentioned title, and date of opening of the Bids on the sealed cover to avoid the Bid being declared invalid. **Vendors desirous of quoting their rates should attach a demand draft of Rs 500 in favour of Principal, Sainik School Kapurthala-144601, and Payable at Kapurthala towards the cost of incidental expenses.**

3. **Bidding terms & Conditions**
 - (a) Bidder should have experience of dismantling work/ O&M (Operation & Maintenance) work in Govt. or Semi Govt. departments.
 - (b) Bidder should have minimum turn over Rs 5,00,000/- (Rupees Five Lac Only) in last three financial years.
 - (c) Bidder must have PAN/ TAN/ GST/ Service Tax/ Sale Tax/ EPF/ Registration Number etc.
 - (d) Bidder must submit photocopies of above mentioned documents along with bid.
 - (e) Bidder should have an office in the state of Punjab.

4. **Submission of Concept Plan:**
 - (a) Proposal to be submitted should be based on highest bidding value i.e. the bidder who bids the highest amount for dismantling the OHSR and Old Bus Garrage and quarters to be deposited with school as credit.

- (b) Bidder has to submit the proposal in a closed envelope.
- (c) Proposal given will be scrutinized by committee constituted under the chairmanship of Principal, Sainik School, Kapurthala.
- (d) Bid shall be received in two envelopes i.e. envelope (A) and envelope (B).

Envelope – A: shall contain turn over supporting documents, similar work and financial credentials such as PAN /TAN/GST etc.

Envelope – B: shall contain the proposal with financial bid.

- (e) Envelope A will be opened first and envelope (B) will be opened for only those bidders whose envelope (A) is accepted after opening by committee.
- (f) If the last date of submission of E.O.I /Date of opening of bid happens to be public holiday then the bids will be opened on next working day at the same time and place.
- (g) Principal, Sainik School, Kapurthala reserves the right to reject any or all bids without assigning any reason.

5. **Other conditions for successful Bidders.**

- (a) Site visit made by bidder as and when required.
- (b) Submission of proposal of execution for dismantling of OHSR and old Bus Garrage and quarters in safe / secure manner to be supplied by the bidder with hard copy and soft copy and shall become the property of Sainik School Kapurthala.

6. **Reserve Amount.**

The school intends to fix the reserve value at Rs 2,13,074/- (Rupees Two Lac Thirteen Thousand Seventy Four Only) for the credit value for dismantling of OHSR and Rs 46,000/- (Rupees Forty Six Thousand only) for the credit value for dismantling of Old Bus Garrage and Quarter. The same to be deposited on the account of Sainik School Kapurthala.

7. **Scope of Work.**

- (a) An OHSR built of bricks and RCC and Old Bus Garage built of bricks and RCC is existing in the campus of Sainik School Kapurthala.
- (b) The school intends to construct a new OHSR after demolition of the existing old OHSR.
- (c) The capacity of the existing OHSR is 80,000 Ltr.
- (d) The OHSR is built in the close to cadets' hostel & infirmary. The demolition has to be controlled and safe.
- (e) The work to be executed with proper safety arrangements to avoid any damage to the life or property during the demolition.

- (f) The responsibility lies solely on the vendor to ensure safe demolition.
- (g) The dismantled material of the demolition to be cleared from the site by the vendor within stipulated time i.e. One (01) weeks from the date of execution of work / receipt of work order.
